
- (a) \$3.50 million is a zero rate loan facility provided by Renaissance Assets Pty Ltd, a related party, with no fixed terms of repayment. No security was given.
- (b) \$1.964 million is a bank bill variable rate facility with a 5 year term expiring August 2023, provided by Bank of Queensland. Interest rates range from 5.00% - 5.50%. Loan is secured.
- (c) \$14.267 million is a bank bill variable rate facility provided by Bank of Melbourne. Terms of a new facility is being negotiated. Interest rates range from 5.60% - 6.05%. Loan is secured.
- (d) \$0.75 million is a commercial variable rate loan facility with a 20 year term, provided by ING Direct. Interest rates 4.34% plus a margin of 0.93%. Loan is secured.
